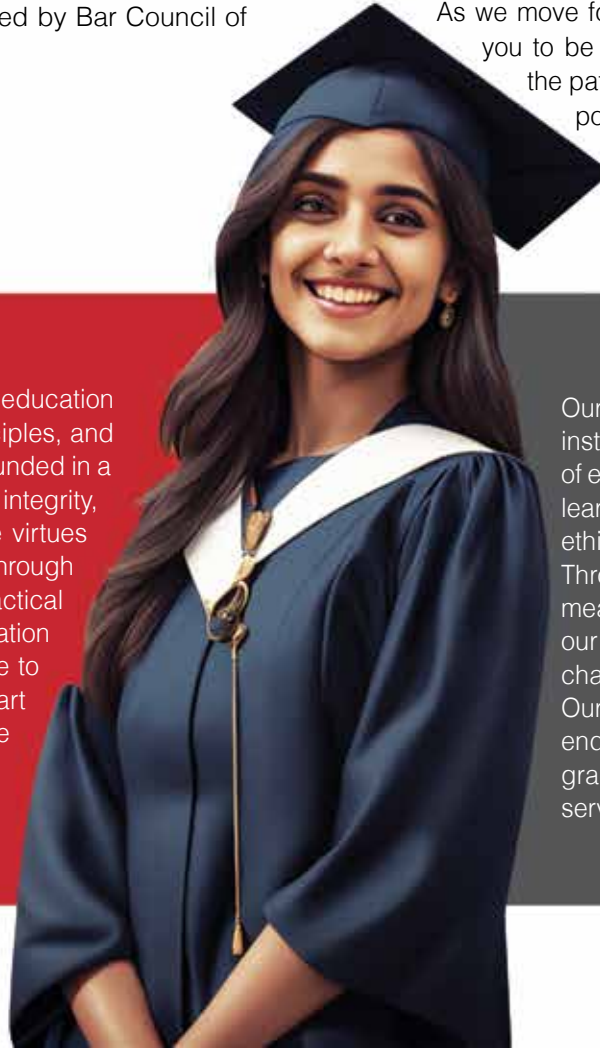

Our Courses

BA LLB B.Com LLB

BA LLB is an integrated undergraduate degree program that combines the study of arts with Legal Studies (LLB). It is a comprehensive course that equips students with a strong foundation in both humanities subjects and legal principles.

B.Com LLB is an integrated undergraduate degree program that combines the study of Commerce (BCom) with Legal Studies (LLB). It is a unique course that aims to provide students with a strong foundation in both commerce and law, enabling them to pursue a career at the intersection of these fields.

Eligibility : A pass in Higher Secondary Examination of the Government of Kerala or any other examination recognized as equivalent thereto by University of Kerala with not less than 45% marks for General category, 42% for OBC and 40% marks for SC and ST.

Duration : 10 Semesters in Five Years

Age Limit : There is no upper age limit for admission to the LLB Courses.

Civil Services Coaching Cell

Divine Law College is the first Law College in Kerala to start Civil Service Coaching Cell within the campus. It has initiated the programme of imparting coaching for Civil Services Examination for those students who are enrolled in this college for the five year integrated BA LLB and B.Com LLB academic programmes.

The Civil Services Coaching Cell was inaugurated by Assistant Inspector General of Police Sri. Suneesh kumar. R, IPS. The five year integrated LLB Degree programme can create a concrete foundation for Civil Services Examination.



Judicial Service Coaching Cell

Divine Law College is the first Law College in Kerala to start Judicial Service Coaching Cell within the campus. The coaching cell was inaugurated by Sri. Jose .N. Cyril, Additional District Judge, Thiruvananthapuram. Judicial Services Exam coaching is a form of preparation that provides candidates with structured guidance to achieve their desired results.

Chartered Accountancy Coaching Cell

Divine Law College is the first Law College in Kerala to introduce coaching for Chartered Accountancy Course inside the campus. A Chartered Accountant is a qualified accountant of the Institute of Chartered Accountants of India. They are required to have sound knowledge of accounting, auditing, costing and various aspects of direct and indirect taxation. Chartered Accountancy is one of the most chosen career options in India. Students from any field can pursue the CA course and add a CA prefix to their name. Students who have completed their 12 th or graduation with at least 55% are qualified to register for the course.



Coaching for Cost and Management Accounting

Divine Law College is the first Law College in Kerala to introduce coaching for Cost & Management Accounting (CMA) inside the campus. The CMA course is offered by Institute of Cost Accountants of India (ICMAI).

A CMA is a person who offers to perform services involving the costing, pricing of goods and carries out the preparation, verification or certification of cost accounting and related statements. CMA assists in planning, monitoring and controlling the cost and price of a product or a service.



Company Secretary Coaching Cell

Divine Law College is the first Law College in Kerala to introduce coaching for Company Secretary Course inside the campus. A Company Secretary is a senior position in the corporate governance of organizations, playing a crucial role in ensuring adherence to statutory and regulatory requirements. They provide legal advice to directors and board members, deal with other professionals like lawyers and auditors and keep up to date with policy, legal and statutory requirements for the business. This position is integral to the efficient functioning of corporations, particularly in common law jurisdictions.



OUR FACILITIES

Moot Court Hall



The Moot Court and Mock Trials are the thrust areas of Legal Education, giving practical exposure to litigation process. By integrating the theory and practice of law through Moot Court and Mock Trial activities the college aims to sharpen the lawyering skills of the students. It further strives to empower students for national and international Moot Court Competitions. Divine Law College is equipped with a state of the art Moot Court hall capable of hosting even International Moot Court Competitions.

Library

The Divine Law College has a full-fledged Law library which functions from 8 AM to 6 PM. The library is equipped with law books including the journals, reference books as well as the text books. The library subscribes Supreme Court Cases, All India Law Reports, Kerala Law Times and Kerala High Court cases. We have back volumes of All India Reporter from many years. The library has separate sections of all the available titles on almost all important branches of law.

Library Rules & Regulations

- Students will not be permitted to use the library during class hours except with prior permission of the authority concerned. They are expected to use the library in their free time and after class hours.
- The identity card is a must for all library transactions.
- Students should fully co-operate with the librarian and the library staff.
- Students of the library should avoid taking out several books or volumes at a time.
- Books must be returned on or before the due date.
- If borrowed books are not returned on time, each day shall entail a penalty of a certain amount of money.
- Reference books are not to be issued, and should be referred to within the library itself.
- Printed matters, Books, Bags, Files, Mobile phones and other personal belongings should be kept outside the library
- If any book is lost, damaged or mutilated the borrowers shall be required to replace the book with fine fixed by the Management.
- Students should clear all dues to library before submitting their application for end semester University examinations. They should obtain a No dues statement from the librarian.

Smart Class Rooms

ANTI-RAGGING CELL

Ragging in all its forms is totally banned in Divine Law College and all its premises. The College shall take strict action like cancellation of admission against those found guilty of ragging and/or of abetting ragging and the burden of proof shall hereby lie on the perpetrator of alleged ragging and not on the victim. An offence of ragging may be charged either on a written complaint by the affected or on independent finding of the Anti-Ragging Cell.

Ragging is a Criminal Offense

As per the Relevant Act, any physical or mental harassment to any junior by senior students is termed as ragging. Ragging in any type by other students within or outside the campus is punishable under the Kerala Prohibition of Ragging Act, 1998 (Act 10 1998). The following types of punishments can be given:

- Dismissal from College
- Imprisonment up to 2 years
- A fine of up to Rs. 100000/-
- Will not be permitted to continue studies in any college for a period of 3 years.

Disciplinary Committee

The disciplinary committee will look after the code of conduct and general rules of the college. Those violate the rules will be penalised accordingly by the above committee

Admission Procedure

Eligibility

1. Candidates should have passed the Higher Secondary Examination of the Board of Higher Secondary Education, Kerala, or any other examination recognized by the Universities in Kerala as equivalent thereto.
2. Candidates must have scored not less than 45% of aggregate marks for those who belonging to the General Category, 42% of marks for SEBC(Socially and Educationally Backward Classes - Ezhava, Muslim, Latin Catholics & Anglo Indians, Dheevera, Viswakarma, Kusavan, SIUC, Converted Christians, Nadar belonging to Christian denominations, Kudumbi and Other Backward Hindhus) and 40% of marks for SC / ST.
3. A candidate who has passed an examination in 10+2 Course of schooling recognized by the educational authority of the Central or State Government or possesses such academic qualifications which are considered equivalent to such 10+2 course by the Bar Council of India can also apply for admission to the course. Applicants who have obtained +2 Higher Secondary pass certificate or first degree certificate after prosecuting studies in distance or correspondence method shall also be considered as eligible for admission.

Mode Of Admission

50% merit seats of our LLB courses will be filled by the Commissioner for Entrance Examinations, Govt. of Kerala through KLEE. And we are conducting an entrance exam (Divine Law Entrance Exam - DLEE) for filling 25% of our management quota seats. If a student is getting admission on this 25% management quota seats, he/she will have to pay only the Government Merit fee. The details and application for the Entrance Exam can be seen in our website www.divinelawcollege.com. The remaining 25% management quota seats will be filled directly by the management without KLEE or Divine Law Entrance Exam.
